Statement for Publication

Anglophiles Academic is a mature organisation with a loyal client base and good reputation. It has been offering a wide range of junior activities with English courses in a variety of locations for many years. Courses continue to be well organised and supervised and attention to the welfare of students in some aspects is excellent. Student satisfaction is generally high.

The organisation has very good systems for reporting and recording its operations and actions. The Head Office staff are dedicated and provide good leadership and support to staff in its centres. There is a strong, hierarchical structure with clear lines of responsibility and accountability to ensure the welfare of junior students. The appointment of a new Academic Manager in 2016 strengthens the management team. The organisation has demonstrated its commitment to implementing refinements to its academic provision to achieve improvements in the support it gives its teachers and ensure consistency in the quality of its teaching across all centres.

The organisation has satisfied the requirements of the ABLS standard identified in the 2015 report and is now ready to move to a four-yearly cycle of inspections.
